### **OTHER ITEMS:**

Mr. Todd Barcus provided the Board with a copy of the Memorandum of Understanding with the Regional Youth Center, which is an agency located in Paden City, and is affiliated with the Wheeling Youth Services. The agency provides therapy for substance abuse, as well as mental health issues for ages 12-24. A second service the agency offers is educational groups. These groups are held in the schools and the idea is to start conversations with the students and to have peer interaction with topics that include proper expression with feelings and emotions, risks and behaviors of substance abuse, respect for authority and property, knowledge of healthy relationships, and proper use of social media.

Mrs. Williams stated she received a request today from the Hundred Young Life leader for a bus and bus operator to transport approximately 15 teens and 2 adults to and from Jackson's Mill, WV for a Fall Weekend event this Friday, November 20<sup>th</sup>, and Sunday, November 22<sup>nd</sup>. This will be funded through the Hundred Young Life. The Board members were in verbal approval of the request, and asked for it to be placed on the next agenda.

### **ADDRESS THE BOARD:**

#### Johnna Harter:

Ms. Harter spoke to the Board to address her concerns regarding an incident that occurred after the Board meeting on November 2<sup>nd</sup> where her son was approached inappropriately by a Board member. She stated she was told by Board members, the State Board, and the West Virginia Department of Education that nothing could be done. She has filed a claim with the West Virginia Board of Ethics, and said she will be circulating a petition to registered voters calling for removal of the board member from office. Mrs. Harter read four of the 'Code of Ethics' for school board members, which she felt pertained to her situation. Mrs. Harter also discussed nepotism in the county's educational system, and the recent concern that newly hired employees are not the most qualified. She stated it is a problem and the county needs a policy, as the students deserve to have the most highly qualified. Mrs. Harter read some of the points from the nepotism section from the West Virginia Ethics Act. She also read policies from Harrison, Putnam, and Kanawha counties regarding nepotism. She urged the school board to look at the problem and adopt a policy regarding it.

# **ADDRESS THE BOARD:**

Terry Glover, retired educator for Wetzel County Schools, thanked the Board for allowing her to speak. She began by stating that after attending the November 2<sup>nd</sup> Board meeting, she left with mixed feelings. Mrs. Glover said the first part of the meeting was very refreshing hearing the reports from the LSIC's from New Martinsville School and Magnolia High School, and said the teachers, principals, and students did an excellent job presenting their plans, their successes, and their needs. She further stated the second part of the meeting left her discouraged and uncertain about the future of Wetzel County Schools. She said that in her 34 years of teaching and counseling, she never witnessed so much dissatisfaction and low morale facing teachers, principals, parents, and students. Mrs. Glover further stated the county has outstanding and dedicated employees giving students the best well rounded education possible, and their efforts should be encouraged and acknowledged, not ignored and changed. She noted the state has implemented many initiatives over the last 49 years and none have been followed through to completion, and said the students suffer during all the transitions in new academic standards.

Mrs. Glover went on to say she was appalled to hear outstanding and highly respected teachers feel defeated and disrespected, and stated the three 'R's' should be replaced with respect, restore, and reunite. Educators have a code of ethics that must be followed. She said respect must be shown to students, teachers, administrators, and parents, and that respect is earned by actions.

Mrs. Glover said that while the Board of Education goals are for curriculum development and raising test scores, she encouraged them to look at the current strategies that are working and work together as a county. Mrs. Glover discussed the number of times teachers are taken out of the classroom for trainings, and requested they be left in their classrooms to teach. She also talked about the traditional math system and pointed out some facts regarding math scores for students taught under the traditional math program versus the new. She said it has been proven that high school grades are a better indicator of college success than test scores, and that not one test can measure a students motivation and desire to learn.

Mrs. Glover went on to discuss the exam policy in the student handbooks, which states they will be exempted from taking exams based upon attendance, grades, and test scores. She questioned why the policy is still being printed in the current handbooks when it was changed in 2012, and now up for first reading for a revised policy. She said we must give incentives to students who perform well, and she feels with the revised exam policy, the attendance and graduation rate will suffer. Mrs. Glover also requested honor roll listings be published in the local newspaper in a timely fashion. She concluded by saying that she believes Wetzel County can succeed if we show respect, restore ideas and activities that work, and reunite and work together so that everyone feels ownership. She requested the remainder of the school year be focused on letting teachers teach, using their own teaching strategies, emphasizing basic skills, and utilizing traditional math curriculum.

Shauna Heil appeared before the Board to address her concerns as a parent and educator. She began by discussing what a focus school is, and stated the designation of a focus school is given when an achievement gap exists between population and subgroups within the school, not because teachers or students are failing, or that test scores are the lowest in the state. She noted the digital divide also adds to the achievement gap in Wetzel County. This exists because many of the students do not have access to computers or internet in their homes. Mrs. Heil also said that computers and lab time is limited in the schools because of the county and state mandated testings. She said that another reason for the achievement gap is that many of the students are taught the common core state standards on their instructional level using differentiated teaching methods, but the same students are then tested beyond their instructional level on the end of the year assessments. She noted the teachers are aware the achievement gap exists and they discuss it every day for solutions. She said while the average students are making gains on the test scores, it adds to the widening of the achievement gap.

Mrs. Heil also discussed testing and the constant changing of the standards and end of year assessments. She said that while the teachers do not have a problem with this, they do have a difficult time with the amount of testing with the addition of the county mandated ICA testing. She also noted that with the number of students at New Martinsville School, it takes a considerably longer amount of time to complete the tests, and the students are missing out on quality instructional class time with their teachers, as well as computer lab time. This type of testing gives zero feedback to the teachers, students, and parents. This only provides a number, and does not provide item analysis or a listing of objectives mastered. She said numbers cannot guide a teacher's or a student's learning goals. She briefly discussed some of the tests they used to give students, including the Star, which assesses student progress in math and reading. She respectfully requested the repeal of the mandate for ICA's.

Mrs. Heil's final point to the Board was in regards to the Literacy Scope and Sequence Training she attended early in the fall. During the training they worked in grade level teams to plan reading units for the year, working from the end of the year to the beginning, which is typical when the teachers plan. Her concern was that they were redirected by the county literacy coaches to plan their units from March, as opposed to May. The literacy coaches were instructed by Mrs. Williams that April and May were to be set aside for testing. As a parent and a teacher, she does not want this for her children or her students.
