The Wetzel County Board of Education met in Regular Session on Monday, November 18, 2013, at the Office of the Superintendent of Schools, in New Martinsville, WV, at 6:30 p.m. The following members were present:

OPENING, PLEDGE OF ALLEGIANCE, AND INVOCATION:

This Regular Session of the Wetzel County Board of Education was called to order by the President of the Board, Mr. Michael D. Blair. Mr. Aberegg led the Pledge of Allegiance to the Flag and Mrs. Gatian gave the opening Invocation.

PRESENTATION:

West Virginia Education Association - Elliott Kendle

Elliott Kendle, WCEA Co-President and WVEA Executive Committee Member, provided the members of the Board with a handout and whiteboard presentation on WVEA's salary campaign. He stated that in the month of September, 748 teachers retired in the state of West Virginia. He noted that it is difficult recruiting teachers with the current salaries offered. The data Mr. Kendle presented showed that West Virginia's average salary ranking is 48th in the nation and West Virginia ranks at the bottom of the neighboring states in average teacher pay. He also stated that according to the West Virginia Department of Education, there were 1,541 education graduates last year, with only 438 of those graduates employed in the state. Mr. Kendle asked the Board to sign a resolution supporting the salary campaign to make the pay of educators competitive with our surrounding states.

Mr. Blair thanked Mr. Kendle for his presentation, and stated "they are very good points". The Resolution will be added to the next meeting's agenda.

New Martinsville Ministerial Association - Vic Hunter

On behalf of the New Martinsville Ministerial Association, Pastor Vic Hunter began by thanking the Board for their service to the children and educators of the community. He spoke to the Board regarding an opportunity to access Universal Free Meals for Wetzel County students in PK-8, and PK-6 at Paden City Elementary, in the year 2014. He encouraged the Board to work toward a serious consideration and possible implementation of the program. Mr. Hunter stated the association has based their appeal on four things: 1) needs assessment, 2) the request for suggestions on how to spend the surplus money for the 2012-2013 school year, 3) benefits assessments, and 4) as religious leaders in the community, they want to attend to the needs of the community in terms of health and education. He stated this program is an opportunity to improve diet, through the universal free breakfast and lunch, which has shown to reflect positive behavior and educational outcomes.

Mr. Blair thanked Mr. Hunter for his presentation. On behalf of the Board, he asked that Mr. Hunter and the Association set up a meeting with Mr. Albright, and for Mr. Albright to get back with the Board.

Glenville State College/Hidden Promise Consortium - Dr. Peter Barr

Dr. Peter Barr presented the Board with information and a whiteboard presentation on the Hidden Promise Consortium through Glenville State College. The College and local school districts are working together on a program that illustrates the importance of higher education. The goals of the project are to increase the number of students graduating from high school and entering college, increase ACT scores, decrease the need for remedial courses, and increase the number of college graduates. The program includes students in the 8th through 12th grade, and criteria includes possible first generation, low to moderate income, and potential to further education to a higher level but needs extra support. Dr. Barr also discussed the JASON project, which is a science-based 5-8 curriculum developed in partnerships with National Geographic Society, NOAA, NASA, and the U.S. Department of Energy. The JASON project is a complimentary project with the Hidden Promise Consortium. The Hidden Promise Scholars are chosen by county superintendents, principals, and counselors. The program provides mentor and family involvement, campus visits, free summer camps, and scholarships. The program not only gets students in to college, but also gets those students out of college.

Dr. Barr stated he was present this evening to ask the Board for a commitment from Wetzel County Schools for the Superintendent to join the Consortium, to identify some scholars, and to allow them to work with those scholars. He stated the program is totally free. The goal of the Consortium is to get more kids to graduate from college.

Mr. Patterson and Mr. Blair both stated the Consortium sounded like a win-win program. Mr. Blair thanked Dr. Barr for coming, and stated the Board would discuss the topic with Mr. Albright and get back with him.
