OPENING, PLEDGE OF ALLEGIANCE, AND INVOCATION:

This Regular Session of the Wetzel County Board of Education was called to order by the President of the Board, Mr. Warren L. Grace, Jr. Mr. Balcerek led the Pledge of Allegiance to the Flag and Mr. Jones gave the opening Invocation.

PRESENTATION:

RESA VI – Nick Zervos

Mr. Nick Zervos, Executive Director of RESA-6, began by thanking the Board, administration, and staff for their active participation with RESA. He presented the annual update on the RESA-6 programs and services provided to the counties in the areas of education, financial benefit, health and safety, and technology. Mr. Zervos said they were able to train over 6,600 teachers and principals last year with professional development, and worked with over 400 educators with the CPI training. They also instituted a Q-Interactive program for the school psychologists to save the schools \$4,000.00. RESA-6 put together a Literacy Grant for \$75,000, and also worked with West Liberty University for a \$37,500 Leaders of Literacy Grant. Mr. Zervos briefly reviewed some of the cost-saving services, including cooperative purchasing and Medicaid reimbursement. He said the Substitute Employee Management System fielded 74,000 calls last year, with a fill rate of 94.1%. He went on to say they offered audiological services for over 350 students and provided public service training classes for close to 5,000 participants. The WVEIS staff assisted over 3,000 system users providing Help Desk assistance to over 15,000 callers.

Mr. Zervos discussed the recent legislative audit on the RESA's. He said RESA-6 received a forty-page audit, and they, in turn, wrote twelve pages of inaccuracies and answered each finding. He also said the State Department and the RESA's were given until January to present a formal response to lawmakers. Mr. Zervos encouraged the Board members to support the RESA's with the local legislators. Mr. Jones commented by saying he was in education before RESA's came in existence, and stressed how involved the RESA's have been with the school systems. He also noted that the value of the services RESA provides to the schools is immeasurable.

Mr. Lancaster said the third option is to hire them, but said they would have restricted limitations in doing that. Following brief discussion, it was decided that County Office Administration will contact the Sheriff's office and the City and will report back to the Board.
