OPENING, PLEDGE OF ALLEGIANCE, AND INVOCATION:

This Regular Session of the Wetzel County Board of Education was called to order by the President of the Board, Mr. Warren L. Grace, Jr. Members of the New Martinsville Cub Scout Pack 102 led the Pledge of Allegiance to the Flag and Mr. Blair gave the opening Invocation.

Mr. Toman recognized the School Resource Officers for Wetzel County Schools. He expressed his appreciation and thanked them for their support and protection they provide to the students. Mr. Grace and Mr. Toman presented each of them with a plaque. (Those marked with an asterisk were in attendance.) Mr. Toman also thanked Mr. Blair, Mr. Balcerek and the previous boards for implementing the resource officers in the schools.

PRESENTATIONS:

JASON Learning – Dr. Eleanor Smalley and Ravi Gorur

Dr. Smalley and Mr. Gorur provided the Board with handouts and a powerpoint presentation on the JASON Learning, which was founded by Dr. Robert Ballard following his return from discovering the Titanic. Mr. Gorur, CEO of ZippSlip, began the JASON presentation and discussed the future of jobs, technology in the 21st century, and the importance of STEM in education and how it effects our lives. He briefly reviewed several innovations, including the invention of the Gutenberg Press, automated looms, the Wright Flyer, Einstein's Photoelectric Effect and Quantum Theory, and how these inventions have led to technology devices and new career paths. Mr. Gorur also discussed the large growth and advantages of the internet in the 21st century. He went on to talk about where things are going with technology, such as cloud computing, artificial intelligence, autonomous vehicles, electric vehicles, robotics, augmented reality, and synthetic biology. Advances in technology that are forthcoming

include thinking machines, low-cost space launch vehicles, high speed transport, and synthetic organs. Mr. Gorur concluded by stating that STEM-related careers are rapidly growing, and students must expect and welcome change.

Dr. Smalley continued with the presentation on the non-profit JASON Learning, which provides curricula that captures the students and gets them excited about learning. JASON has two missions: to inspire students to take STEM subjects and consider STEM careers; and to excite, instruct, and re-energize teachers. The strategy is to create motivation to learn, keep the students engaged, and stimulate intrinsic achievement and personalized learning. Dr. Smalley provided examples and pictures of people who became scientists, engineers, and astronauts through great STEM role models and mentors they learned from.

Dr. Smalley also showed pictures of students at Acadia National Park and Cape Eleuthera Island, which demonstrated students engaged in real science. She said they connect kids with role models, such as scientists, mathematicians, and engineers. She provided a slide which showed the projected percentage increases in STEM jobs from 2010-2020. Dr. Smalley reviewed the various STEM curricula, including Monster Storms, Resilient Planet, Terminal Velocity, Wetlands, and Recycling. JASON works with scientific organizations, such as NASA, NOAA, National Geographic, and Oak Ridge. They connect with the organizations and teach to the standards. She went on to discuss the student and teacher "Argonaut Program". Wetzel County Schools will select one student and one teacher as Argonauts, and they will travel next summer to a research location to work side-by-side with scientists and engineers. When they return, they will be role models for their peers. JASON includes scientific content, videos, classroom and field labs, invitations to join Missions, hands-on labs, and inquiry-based field assignments. Mini-games are also provided to help students reinforce key concepts.

JASON also provides school district Argonaut challenges and competitions, as well as Argonaut multi-week summer expeditions and explorations. Dr. Smalley stated that 96% of National Argonaut's have gone into STEM careers. She said JASON is standards-based, trying to make it engaging, interesting, and easy for teachers. Some of the corporate sponsors include Chevron, Dell, ZippSlip, Shell, and the International Spy Museum.

Dr. Smalley concluded stating she is very excited to work with Mr. Toman and Wetzel County Schools. She said Mr. Toman is offering this to every student in the county. JASON continues to develop new curriculum, and the goal is for the kids to get access to the curriculum and learning experiences in science, technology, engineering, and math.

Mr. Jones expressed his appreciation for the JASON program. He praised the previous Board for having the foresight to assure our kids are engaged in this enough that we are having 1:1 computers for every student in Wetzel County. Mr. Toman stressed how excited he is to get this started, and said every teacher that he has seen go through the JASON training has been excited with the program. He said it is about getting kids engaged and excited to learn. Mr. Toman thanked Dr. Smalley and Mr. Gorur for the presentation.

WVEA - Elliott Kendle

Mr. Elliott Kendle, teacher and WCEA Co-President, made a presentation to the Board on the WVEA's stance on the state's A-F grades for our schools. Mr. Kendle stressed that his comments were not about any particular school, but to remind the Board and audience of what the scores represent and to provide an understanding of what the schools are doing to ensure student success. He said that 83% of the A-F relies on the standardized test results in Math and English Language Arts. Mr. Kendle said there is no evidence that it leads to sustained school improvement in the other states that use the grading system. He also noted that the data on which the grades are based is not the foundation for what teaching is about, and it does not give parents an accurate description of what occurs each day in the school.

Mr. Kendle went on to say the test itself was designed to be a diagnostic guide to help inform instruction and curriculum, not to be used for the purpose of grading our schools. He stressed our schools have too many variables and many different components that make up what happens each day in our schools, and stated that the grading of schools based on the standardized test is limited. He also assured, "our schools and educators are accountable each day for what occurs in their classrooms and are proud of what goes on in their classrooms". Mr. Kendle said the teachers work to adapt their instruction to ensure every student achieves to their full potential.

He concluded by saying, "what happens in our schools each day is magical and it can never be measured by a letter grade on a test."
