OPENING, PLEDGE OF ALLEGIANCE, AND INVOCATION:

This Regular Session of the Wetzel County Board of Education was called to order by the President of the Board, Mr. Michael D. Blair. Mr. Balcerek led the Pledge of Allegiance to the Flag and Mr. Blair gave the opening Invocation.

The order of 'Presentation' items was changed from the agenda, having READ 180/SR 44 before Energy Express.

PRESENTATION:

READ 180/SR 44 - Diane Brown

Tammy Wells, Administrator, began the presentation with a brief history of the literacy needs for the county's adolescent population. She noted that with the initiation of the READ 180 program, along with the academic skills of our faculty, Wetzel County has seen marked gains in reading achievement in the adolescent students.

Diane Brown, Special Education teacher and READ 180/SR44 teacher, reviewed some of the successes with the program at Magnolia High School. Mrs. Brown said that READ 180 is a program with high-interest stories designed for young teens and young adults. Every program starts with a video clip and then the stories are done in a large group, followed by discussions for comprehension and activities on vocabulary and writing. The students then work individually online where they are leveled according to their test results. Mrs. Brown said the teachers are able to monitor and address individual specific targeted needs. She also stated they have initiated the SR44 program which is an intervention for students who test below the READ 180 level. Mrs. Brown said this program has been very successful in getting the students to transition to the READ 180 level. A large number of students have shown growth and several have moved to regular reading classes. She also said this program has been implemented in the lower grades.

Amy Littell, Special Education teacher and READ 180/SR44 teacher, discussed some of the experiences and successes with the program at the junior-high level at New Martinsville School. She stated they began the program this school year, and noted that three students have grown over 100 points on the Lexile since beginning the program. She has started a "100-point" club which the students are really excited about. Mrs. Littell thanked the Board for purchasing the program.

Mr. Blair stated he has heard good things about the program. Mrs. Wells also distributed notes from other teachers in the county who are using the program with great successes, along with information on Lexile.

Energy Express - Shane Highley, Mollie Toppe

Shane Highley, Administrator, and Mollie Toppe, WVU Extension Agent, provided the Board with a handout and a power point presentation on Energy Express, an 8-week AmeriCorps summer reading program being reintroduced to Wetzel County this summer. The first two weeks of the program is for training the college student mentors, and the following six weeks is for the actual student program. Energy Express uses place-based curriculum with weekly themes, it incorporates family style meals, and encourages parent and community involvement and collaboration. The students in the program will be placed in small vertical age groupings and will work on reading, writing, art, drama, noncompetitive play, and take-home books. The program allows parents and families to come visit, and offers many opportunities for volunteers. Mr. Highley said they have distributed applications for mentors and site coordinators. Wetzel County will have three Energy Express sites, and each site will consist of 40-64 elementary age children, one Site Coordinator, one or two Community Coordinators, and five to eight mentors, along with family and community volunteer members, and local partners. Mr. Highley said he is looking forward to this program and invited the Board members to visit. Ms. Toppe said it is one of the best programs the Extension Agency offers. Mr. Patterson asked Mr. Highley and Ms. Toppe to come back in September to report on the successes of the program.

Long Drain School and Hundred High School are Partners in Education with the bank.

Mr. Albright announced that the All-County STEM Competition held last week at Valley High School was very successful.

Mr. Albright stated that Ben McPherson received information on Friday for a Web Design Conference in Pittsburgh, PA on February 10th. He said that one of the goals is to redesign the school and county websites, and he would like for Adam Herrick to attend this conference. Since the notice was received after the agenda for tonight's meeting was published, Mr. Albright asked for Board approval, and stated the information will be placed on the next Board agenda. The Board was in agreement.

Mr. Blair asked Mr. Albright where we stand with the county school system's involvement with drug awareness programs with the County Commission, local police, state police, and sheriff's department. Mr. Albright said we are working with a program with Jim Robinson called 'Project Purple'. He informed the Board that he does not have the final details, but sometime in April a speaker will be coming to speak to the high schools.

Mr. Yeager distributed a handout to the Board and discussed the current personnel season, the timelines, and the law concerning classroom ratios. He reviewed and discussed the current school year number of students per grade, the number of teachers, and the projected enrollment numbers for next school year for each of the elementary schools. The Board was in agreement that better instruction is given to students in smaller classroom sizes.
