Transportation Ballot:

Approval of the Transportation Ballot, which was voted on by all regular school bus operators by secret ballot on January 23, 2015, which stated the following:

"Midday extracurricular (shuttle) school bus runs will continue to be assigned by seniority on a rotating basis, which has been past practice. Midday extracurricular (shuttle) school bus assignments will continue to be posted each school year by attendance area."

The final vote was 21 bus operators for continuing the past practice as stated above, and 7 bus operators voting against the past practice. A two-thirds majority vote is needed and was obtained (75%).

Mr. Salva also stated that several students placed in the Math Field Day competition.
