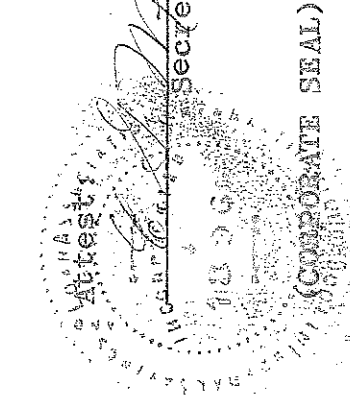
PARTIAL RELEASE
